

1. Background

The EIT Climate-KIC Start-up Acceleration Programme, working under the aegis of the European Institution of Innovation and Technology (EIT), opens this call in six European regions, including Hungary. The programme for local start-ups offers a business oriented, 3 stages acceleration model, including access to financial grants, knowledge transfer, full-scope business skills training and network to investors & EIT Climate-KIC international community.

In essence, the acceleration programme educates start-ups to business planning, presentation and negotiation technics and other business skills by high-profile business experts. To transform a start-up idea into a viable and market-ready enterprise they get access to EIT Climate-KIC's international network (e.g. European master-classes, global exhibition opportunities) as well as non-refundable financial support (grant) up to EUR 50.000.

2. Start-up development

The Entrepreneurship Programme of EIT Climate-KIC aims to:

- 1. Generate more cleantech start-ups and accelerate their successful market entry;
- 2. Help existing cleantech starters to grow faster;
- 3. Provide growth to existing business with a positive climate impact across Europe.

Growing cleantech innovations into valuable, innovative and successful businesses is the goal of EIT Climate-KIC Acceleration programme. Its vision is to create a world-class support infrastructure for cleantech starts in the early phases. This should lead to more cleantech entrepreneurs developing faster and with a higher survival rate, boost start-ups growth and turn them into worldwide exporters of clean technologies.

It is implemented in a systematic 3-stage approach to help entrepreneurs to develop and implement their business plan:

Stage 1: Idea generation, fundamentals and business model

Stage 2: Market Validation

Stage 3: Delivery and growth



3. Application terms & activities per stage

The following is expected from each applicant when entering any of the 3 stages of EIT Climate-KIC Acceleration programme:

Stage 1	Idea generation, fundamentals, business model	
Open to motivated entrepreneurs with an innovative business idea and/or proof of breakthrough technology that has a substantial climate impact.		
Duration of Stage 1	6 months	
Application	Application form. Please fill it out on our <u>website</u> .	
Awards	Individual coaching/mentoring sessions. Access to business experts of the programme to help in general support & specific advice and guidance.	
	Access to EIT Climate-KIC masterclasses/network/local events. The most promising start-ups receive non-refundable grant.	
Stage gate	At the final presentation start-ups are evaluated based on a 5 minutes pitch and 5 minutes Q&A.	
Deliverables	Business Model	

Stage 2	Market Validation	
This stage is open to teams with a developed fundamentals deck and/or a developed business model. The objective is to validate all fundamental assumptions done at Stage 1 and to prepare for market entry.		
Duration of Stage 2	6 months	
Application	Successful graduates of Stage 1 have auto entry, while those who apply directly to Stage 2 should fill out the application form on our <u>website</u> + Skype interview.	
Awards	Individual sessions. Access to business experts of the programme to help in general support & specific advice and guidance. Access to EIT Climate-KIC masterclasses/network/local events. The most promising start-ups receive non-refundable grant.	
Stage gate	At the final presentation start-ups are evaluated based on a 5 minutes pitch and 5 minutes Q&A.	
Deliverables	Market validation result report	

Stage 3	Delivery and growth	
This stage is open primarily for the best Stage 2 start-ups. It will help them to turn the validated deal into a real business proposition. Start-ups will meet potential clients and real investors.		
Duration of Stage 3	6 months	
Application	Only successful Stage 2 graduates can enter the programme at this stage.	
Awards	Tailor made coaching and mentoring.	
	Access to EIT Climate-KIC masterclasses/network/local events.	
	The most promising start-ups receive non-refundable grant – it can be up to	
	50.000 EUR during the whole programme.	
Stage gate	At the final presentation start-ups are evaluated based on a 5 minutes pitch and 10	
	minutes Q&A.	
Deliverables	Investor pitch deck and one pager

Applications ideally focus on the following priorities:

- 1. Renewable Energy (e.g. solar energy, energy efficiency increasing innovations)
- 2. Organic material technologies (e.g. biogas)
- 3. Waste management
- 4. Climate-smart agriculture
- 5. Smart cities (e.g. city infrastructure)
- 6. "Green vehicles" (new innovative, climate positive vehicles)
- 7. Retrofit solutions
